Students who pursue Clinical Mental Health Counselor certification must follow the same procedures and meet the same requirements for admission to the Graduate School and graduate Counseling Psychology program as degree seeking students. In addition, students must have an earned master’s degree in counseling, counseling psychology, clinical psychology, or a related field from a regionally accredited institution of higher education. Admission to the university will be as a non-degree seeking student. Students who wish to pursue an additional graduate degree should seek a different option or be aware that no more than six hours of study completed as a special non-degree seeking student may be applied to a second master’s degree program.

The National Board of Certified Counselors (NBCC) establishes the academic, experience, and examination requirements for the Certified Mental Health Counselor (CMHC). Students who graduate from Tarleton State University with a master’s degree in counseling or counseling psychology may need as few as 12 additional hours of study to meet the 60 credit hour academic requirement for this certification. The NBCC solely determines the suitability of coursework and an applicant’s eligibility for the CMHC credential. This advising guide is based on available courses at TSU that are most likely to meet the NBCC’s requirements.
