## Master Course Syllabus Outline

Department: Management, Marketing & Administrative Systems  
Course Prefix/Number: MGMT 450  
Course Title: Management Information Systems  
Master Syllabus Approved by Department on: 12/1/08

- I. Catalog Description:  
This course investigates management issues related to business information systems designed to meet the informational needs of the various business subsystems. The concepts of systems development, security, privacy and ethics associated with information systems are stressed. Credit will be awarded for only 1 of the following courses: ACC 450, CIS 450, or MGMT 450.
- II. Prerequisite: CIS 103 or 3 hours Advanced CIS or ACC/CIS 301 and Junior classification
- III. Expanded Course Description: The course is primarily for juniors or seniors seeking a Bachelors Degree in a business related discipline. The course is based on the idea that information systems knowledge and project management skills are essential for CIS and Business students. That knowledge is mandatory for creating competitive businesses, managing globally, developing and providing products and services to customers.
- IV. Intended Student Outcomes:
  - Know the different technology infrastructures – hardware, software, data, and Networks
  - Understand the business value of systems
  - Understand how organizations are redesigned with info systems
  - Understand the methods used for knowledge management
  - Understand project management for information systems building
  - Understanding information systems security needs and controls
  - Know the ethical and social impact of information systems
  - Know the ethical responsibilities of information systems managers
  - Understand managing international information systems
  - Understanding total cost of ownership issues
  - Understanding electronic commerce issues
  - Understanding information systems organizations, management and strategy

- Know the fundamental types of information systems
