Water Resources Engineering. (3-0) Steady and unsteady flows through channels and man-made structures; sizing of bridge and culvert openings, conduit, and dam storage; analysis of river systems; selection of pumps and turbines; consideration of socioeconomic factors of water resources; and introduction to hydraulic models such as HEC-RAS. Credit for both HYDR 410 and ENVE 410 will not be awarded. Prerequisite: HYDR/ENVE 300; HYDR/ENVE 310; and MATH 333.
