Best Conference Paper: One conference research manuscript will receive the best manuscript award. The winning manuscript will receive an expedited review for publication consideration in the Advances in Business Research Journal. The cash award will be \$500.

Best Faculty-Student Paper Award: One conference research manuscript will receive the award. The winning manuscript will receive an expedited review for publication consideration in the Advances in Business Research Journal. The cash award will be \$500.

Faculty-Student Research Award: One faculty member who mentored the most quality students' submission will receive the award. The cash award will be \$300.
