

## Export Control Purchasing Guidance

*The purpose of this guidance document is to provide a list of items, materials and software (collectively, “products”) that may be subject to export controls and thus highly regulated and require export control compliance review and approval.*

- **If you answer yes for product(s) you will be receiving or purchasing, the purchase will require export control compliance review and approval.**
- **If no to all of the below, then export control compliance review is not needed.**

Sample of where to look for vendor disclosures:

- In quotation documentation or on the Purchase Order or analogous purchase documentation (Master Purchase Agreement)
- On the commercial invoice that accompanies the item
- On a product specification web page
- On a Certification issued by the vendor (requiring the University to acknowledge in writing the export controlled status of the item)
- On an electronic notification form or letter
- On the soft copy of an operational manual
- Software license (or related Terms/Conditions)
