 - ____ Does not take or show initiative in the learning environment.

- ____ 4. **Professional Conduct** – The student does not assume responsibility for utilizing professional teaching practices or does not continuously strive to improve through professional growth.
 - ____ Rejects or ignores constructive feedback and/or is unwilling to improve attitude and performance.
 - ____ Dresses unprofessionally, inappropriately, or exhibits poor personal hygiene.
 - ____ Acts irrationally or impulsively.
