Language, Philosophy and Culture (from THECB Chapter 4: 4.28)

- Courses in this category focus on how ideas, values, beliefs, and other aspects of culture express and affect human experience.
- Courses involve the exploration of ideas that foster aesthetic and intellectual creation in order to understand the human condition across cultures.

The following four Core Objectives must be addressed in each course approved to fulfill this category requirement: Critical Thinking Skills, Communication Skills, Social Responsibility and Personal Responsibility.

- Critical Thinking Skills: to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information;
- Communication Skills: to include effective development, interpretation and expression of ideas through written, oral and visual communication;
- Social Responsibility: to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities
- Personal Responsibility to include the ability to connect choices, actions and consequences to ethical decision-making

Rationale for Inclusion in this Category:

HIST 102, World History Since 1700, fits well into the "Language, Philosophy, and Culture" foundational component area. The central theme of the course focuses on how ideas, values, beliefs, and other aspects of culture express and affected the human experience in the past. Moreover, the course does not emphasize one particular society over the others, but instead provides students with a truly global framework for the concepts presented in this class. The course also stresses the process of intellectual and artistic creation in the past, once again within a global context. Finally, the course also provides an excellent vehicle in which to promote Critical Thinking Skills, Communication Skills, Social Responsibility, and Personal Responsibility. This course, in short, will provide an excellent and effective means to deliver the key goals of the "Language, Philosophy, and Culture" Foundational Component Area.

<u>Course SLO(s):</u> 1) Students will explain the major cultural, political, social economic developments in world history since 1700, especially in terms of their influence on the human experience. 2) Students will use the information from diverse primary documents from throughout the world to construct valid explanations for the major cultural, political, social, and economic developments in world history since 1700.

<u>Learning Activities:</u> Classroom lectures, classroom discussion, and reading assignments

<u>Means of Assessment:</u> Embedded questions in selected tests for each item within both Course SLOs

Core Objective: Communication C1: Students will express ideas in written, visual or oral forms to a range of diverse audiences in multiple settings.

<u>Course SLO(s)</u>: Students will express themselves effectively in written essays on tests on World History since 1700.

<u>Learning Activities:</u> Lectures, classroom discussions, and practice essay-writing exercises

<u>Means of Assessment:</u> Embedded essay questions on selected tests, graded according to a rubric.

Core Objective: Social Responsibility SR1: Students will demonstrate an understanding of different cultural perspectives.

<u>Course SLO(s)</u>: Students will use information about World History since 1700 and apply the historical process to the understanding of current issues

<u>Learning Activities:</u> Reading assignments and classroom discussions

<u>Means of Assessment:</u> Embedded questions, which will require application of information on world history to the understanding of current issues, on selected tests

Core Objective: Personal Responsibility PR1: Students will demonstrate an understanding of ethical standards as applied to decision-making

<u>Course SLO(s):</u> 1) Students will critique the ethical standards that influenced the decisions of leaders throughout the world from 1700 to the present day. 2) Students will critique the ethical lessons and guidelines provided by intellectuals and artists in their work from 1700 to the present day.
