Creative Arts (from THECB Chapter 4: 4.28)

- Courses in this category focus on the appreciation and analysis of creative artifacts and works of the human imagination.
- Courses involve the synthesis and interpretation of artistic expression and enable critical, creative, and innovative communication about works of art.

The following four Core Objectives must be addressed in each course approved to fulfill this category requirement: Critical Thinking Skills, Communication Skills, Teamwork and Social Responsibility.

- Critical Thinking Skills: to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information;
- Communication Skills: to include effective development, interpretation and expression of ideas through written, oral and visual communication;
- Teamwork: to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal.
- Social Responsibility: to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.

Rationale for Inclusion in this Category:

MUSC 325: Jazz History emphasizes Critical Thinking, Communication, Teamwork, and Social Responsibility. Moreover, this course gives students the opportunity to gain historical perspective, have a richer understanding of the basic elements and vocabulary of jazz, be aware of the controversial aspects of blues and jazz, have a deeper appreciation of the role that jazz played in the world history of music, and understand how the style known as jazz changed across time. MUSC 325 will be the only upper-level music course in Tarleton's core. It should remain a part of Tarleton's core offerings since it offers general students a more challenging option as their Arts Core requirement. It also serves Tarleton students since it can help fulfill the required 45 upper-level hours needed for graduation. Though this class may not be the right choice for all students, having the option for a more rigorous core class, meeting diverse degree options, optimizes Tarleton's ability to provide excellence for our students without any liabilities.

<u>Means of Assessment:</u> Common rubric with two graders will be used to grade research paper; rubric criteria will include items pertaining to writing style and vocabulary.

Core Objective: Teamwork TW1: Students will work in coordination to complete specific tasks.

<u>Course SLO(s)</u>: Students identify how communication affects the performance of jazz; students evaluate evidence in informative context; students participate effectively in small groups.

<u>Learning Activities:</u> Graded group project that encourages the students to explore specific jazz topics.

<u>Means of Assessment:</u> Common rubric with two graders will be used to grade the teamwork process as well as the content of the group project.

Core Objective: Social Responsibility SR1: Students will demonstrate an understanding of different cultural perspectives

Course SLO(s): Students recognize the role jazz music plays in different cultures

Learning Activities: Class lectures, guided listening assignments, concert attendance

Means of Assessment: Embedded questions on tests.
