Accounting, Finance, and Economics	ACC-MAcc - ACC-MAcc: Master of Accounting in Accounting	This change reflects our practice of requiring Federal Income Tax I (ACCT 5305) or equivalent. To this point, we have allowed students to complete this course, when necessary, while completing other program requirements. Most candidates entering the MAcc program have already completed a Federal Income Tax I course. (Any student having completed a BBA in accounting will have already completed Federal Income Tax I, which covers taxation of individuals.) This change, coupled with implementation of proposed revisions to DegreeWorks, will make it straightforward for students to plan their coursework and for administrators to confirm completion of all program requirements. This revision does not change our existing practices (from the inception of the Master of Accounting program); it merely enables more efficient handling of student coursework planning.	P161	Fall 2022
