Social Work	SOCW 5316	We are modifying our curriculum to have more overlap between the two concentrations in our MSW program. The initial curriculum did not include an Advanced Policy & Advocacy course, and we believe that this is an area that was lacking in the original plan. By combining some other courses between the two concentrations, we have enough hours left in the MSW degree to require this course.	C3870	Fall 2020
Accounting, Finance, and Economics	ACCT 5330	The two educational objectives of the Master of Accounting Program are: 1) To prepare students as professional accountants in public practice or in business and 2) To develop each students intermediate proficiency in all technical competence areas of accounting generalists and to develop advanced proficiency in financial accounting & reporting and at least one other accounting technical competence area (taxation, audit & assurance, accounting information systems, managerial accounting). Adding this Advanced Managerial Accounting course will allow students to develop advanced proficiency in managerial accounting. At present, we are able to only develop students' advanced proficiencies in four of five of the technical competence areas of accounting. We have offered this course as a "Problems" course the past three Spring semesters.	C3858	Fall 2020
