

Tuition Rebate for Qualified Undergraduates

This form must be received by the Office of the Registrar on the Friday the week before commencement.

Any applications received after this time will not be considered.

You may be eligible for up to \$1,000 to be applied to your student loan or a rebate of up to \$1,000 if you have no student loans upon graduation. Detailed information can be found at

You must meet the following criteria:

- You have been a Texas resident and entitled to pay in-state tuition at ALL times while pursuing your degree.
- This is your FIRST baccalaureate degree.
- You have no credit hours prior to Fall 1997 semester:
 - This does not include CLEP hours
 - This does include college hours taken during high school
- You attempted no more than 3 hours above the minimum credit hours required to complete your degree plan (hours for minors are included in your credit hours unless the minor is required by the degree).
 - Attempted hours include:
 - Transfer credits (includes credits from all other institutions of higher education)
 - All credit earned by examination in excess of 9 hours
 - Courses that are dropped after the official census date
 - Optional internship and cooperative education courses
 - Developmental courses
 - Repeated course
 - Attempted hours *do not* include:
 - Dual credit hours earned in high school
 - The first 9 credit hours earned by examination
- If you graduated high school in the fall of 2005 or later, you are graduating in a timely manner which is typically 4 calendar years. If you graduated in the summer of 2005 or earlier, this rule does not apply.
- You have paid some amount from non-gifted aid (i.e. personal funds or loans) to cover tuition expenses. Students who have been exempt from the payment of tuition will not be eligible to receive the rebate.

Tuition rebates will be applied to any outstanding student loan owed to or guaranteed by the State of Texas. If a student has more than one outstanding student loan, Tarleton State University will apply the amount of the rebate to loans as directed by the student. If the student fails to provide timely instructions on the application of the amount, Tarleton State University will apply the amount of the rebate to the loans with the highest interest rate first. If a student has no outstanding loans, a rebate check up to \$1,000.00 (based on the amount the student paid) will be issued to the student.

Approximately 6 weeks after the semester concludes in which you are graduating, an email will be sent to your go.tarleton.edu email account informing you of the tuition rebate decision.

Rebate checks are mailed to the current mailing address on file. It is your responsibility to update your mailing address.
