

**Spring 2018**

- ✓ University SACSCOC Reaccreditation Steering committee (USRS) fully operational and distributes first report on data availability and reported uses
- ✓ Quality Enhancement Plan committee (QEP) to be organized. Will work closely with USRS
- ✓ Visit with reaccreditation team at some University that has recently been reaccredited (potentially UNT)

**Summer 2018**

- ✓ Naming of new university SACSCOC Liaison
- ✓ SACSCOC Summer Institute – Atlanta, GA – July 22-25. SACSCOC Liaison and USRS and QEP co-chairs as potential attendees

**Fall 2018**

- USRS subcommittees to facilitate in “repairing” missing evidence needed for reaccreditation – writing can begin on “compliant” sections with first draft due December 3 (Deliverable #5)
- Subcommittees with concerns from Spring deliverables should have a plan in place with the Co-Chairs by October 15
- Internal Editor will help design the style guide for the documents, will perform an initial editing on the rough drafts.
- ✓ Discussion of external editor
- ✓ QEP process starts with meetings of the QEP Committee and discussion with Colleges.
- ✓ Create a list of potential topics from QEP for university consideration. Thought having been given to tie-in to University Strategic Plan, Student Success and Student Learning.
- ✓ SACSCOC Annual Meeting – New Orleans, LA – December 8-11. University Administrators will be attending the organizational meeting for the 2021 reaccreditation cohort.

**Spring 2019**

- QEP discussions with various groups seeking decision on a topic with continued thought to University Strategic Plan
- Internal Editor return edits from first draft to Sub-committees by early February
- Re-write of first draft of Compliance Report by Sub-committees by April 15
- SACSCOC co-chairs to coordinate selection of a local mock Off-site review team to be operational in Fall 2019. Potentially may wish to select a local mock On-site review team to be operational in Spring 2020
- Research utilizing an external consultant for compliance report review.
- Run mock Faculty Roster for 18-19 and review – April 30 – June 5

**Summer 2019**

- Comments and edits complete on second drafts of Compliance Report by Internal Editor by June 5
- Re-write of Compliance Report drafts by Sub-committees as needed June and July
- SACSCOC Summer Institute – Dallas, TX – July 21-24
- University VPs, SACSCOC liaison, and University President sign-off on Draft of Compliance Report to go to mock Off-site review team in Fall 2019 – due to cabinet Aug. 15.

**Fall 2019**

- Begin external financial review of 2018-2019 fiscal year
- Input from Mock Off-site review team – due October 1.
- Update and submit to external review consultant – due November 1.
- Consider when to schedule visit by SACSCOC Vice President.
- SACSCOC Annual Meeting – Houston, TX – December 7-10. This may be an opportunity for several from Tarleton to both attend and/or make presentations

**Spring 2020**

- Mock On-site review team (local). = Likely inclusion of visit to at least one non-Stephenville campus
- QEP topic choice to be made by university and decisions made about budget for QEP and decisions about likely “slow roll out” in Fall 2020
- Complete external financial audit of 2018-2019 fiscal year

**Summer 2020**

- SACSCOC Summer Institute – Orlando, FL – July 19-22. Committee chairs and those most involved in writing of reports and coming implementation of QEP should attend
- There should be discussion of likely dates and such related to coming On-site team visit (March 8-11, 2021)
- University approval by President, VPs, and SACSCOC Liaison of Compliance Report to be submitted to SACSCOC Off-site Review Team

**Fall 2020**

- Submission of Compliance Report to SACSCOC Off-site Review Team
- Report received from SACSCOC Off-site Review Team
- Entire university must be poised to respond to comments from SACSCOC Off-site Review Team in a matter of a few weeks and to produce a Focus Report well before the On-site visit coming in Spring 2021
- Fix dates for On-site team visit in Spring 2021
- SACSCOC Annual Meeting – Nashville, TN – December 5-8. Opportunity for clarification from COC Vice President about current status of university statements about Off-site team review and likely final arrangements for On-site review team visit

**Spring 2021**

- All hands on deck
- Everyone at the university should be aware of the proposed QEP topic
- SACSCOC On-site review team visit on March 8-11, 2021

**Summer 2021**

- Top university administrators and key committee members must be prepared to respond to requests for information that may come from SACSCOC after the On-site review team visit.
- SACSCOC Summer Institute (site not yet specified)

**Fall 2021**

- Everyone ready to take care of any items that can be addressed
- QEP topic approved by SACSCOC On-site Review Team to be implemented. Assessment processes will need to be in place
- SACSCOC Annual Meeting (site not yet specified) – Announcement of Tarleton State University reaccreditation by SACSCOC

**Spring 2022**

- If there are minor issues identified in the SACSCOC reaccreditation then university must plan for appropriate response
- Continued and continual emphasis on uses of assessment
- Data collection and assessments concerning QEP
- Implement continuous Reaffirmation process
- Move toward Fifth-Year Interim Report
