#### **Biographical Note/Organizational History**

Danny "Dan" Frank Malone was born on January 22, 1955 in Dallas, Texas. He earned a bachelor's degree from University of Texas at Austin in 1978 and graduated from the University of North Texas with a master's of journalism in 2006. Malone started his career as an editor for the *Daily Texan* from 1977-1978. He was a staff writer for the *Dallas Morning News* (1985-2002), and a staff writer for the *Fort Worth Weekly* (2001-2006). During that time, he was also an adjunct instructor at University of North Texas from 2002-2005, and an assistant professor in journalism at Tarleton State University from 2006-2021. In 1992, Malone and Lorraine Adams won the Pulitzer Prize in Investigative Reporting. Malone was co-recipient of the 2006 Freedom of Information Foundation of Texas' James Madison Award for the "Light of Day" project that involved journalism students from Tarleton State University, University of North Texas, UT-Arlington, TCU, and SMU. He won the 2010 Open Doors Award from the Forth Worth Chapter of the Society of Professional Journalists.

#### **Scope and Contents**

This collection documents the activities of Danny Frank "Dan" Malone, a Pulitzer Prize winning journalist and an assistant professor of journalism at Tarleton State University, and journalism students working on the Light of Day Project. The students contacted various law enforcement departments across the state of Texas in order to obtain these documents, and some law enforcement departments chose not to participate in this project. Materials are largely textual consisting of "use of force" reports, offense or incident reports, domestic disturbance reports, training injury reports, use of taser reports, and policies regarding the use of any non-lethal weapon by any officers. Other formats included in the collection are photographs of injuries.
